- TWO DANISH DESIGN LEGACIES UNITED**

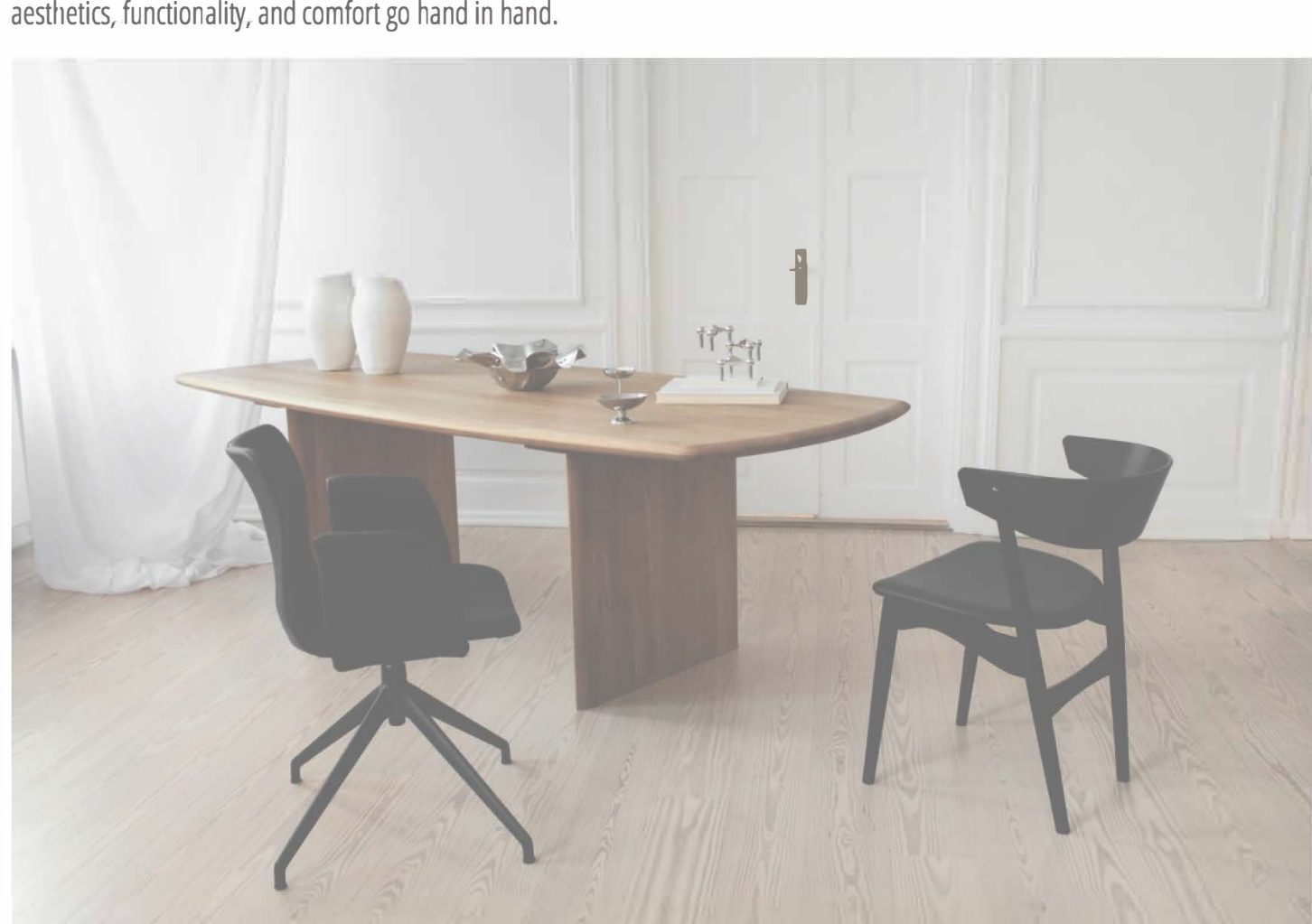

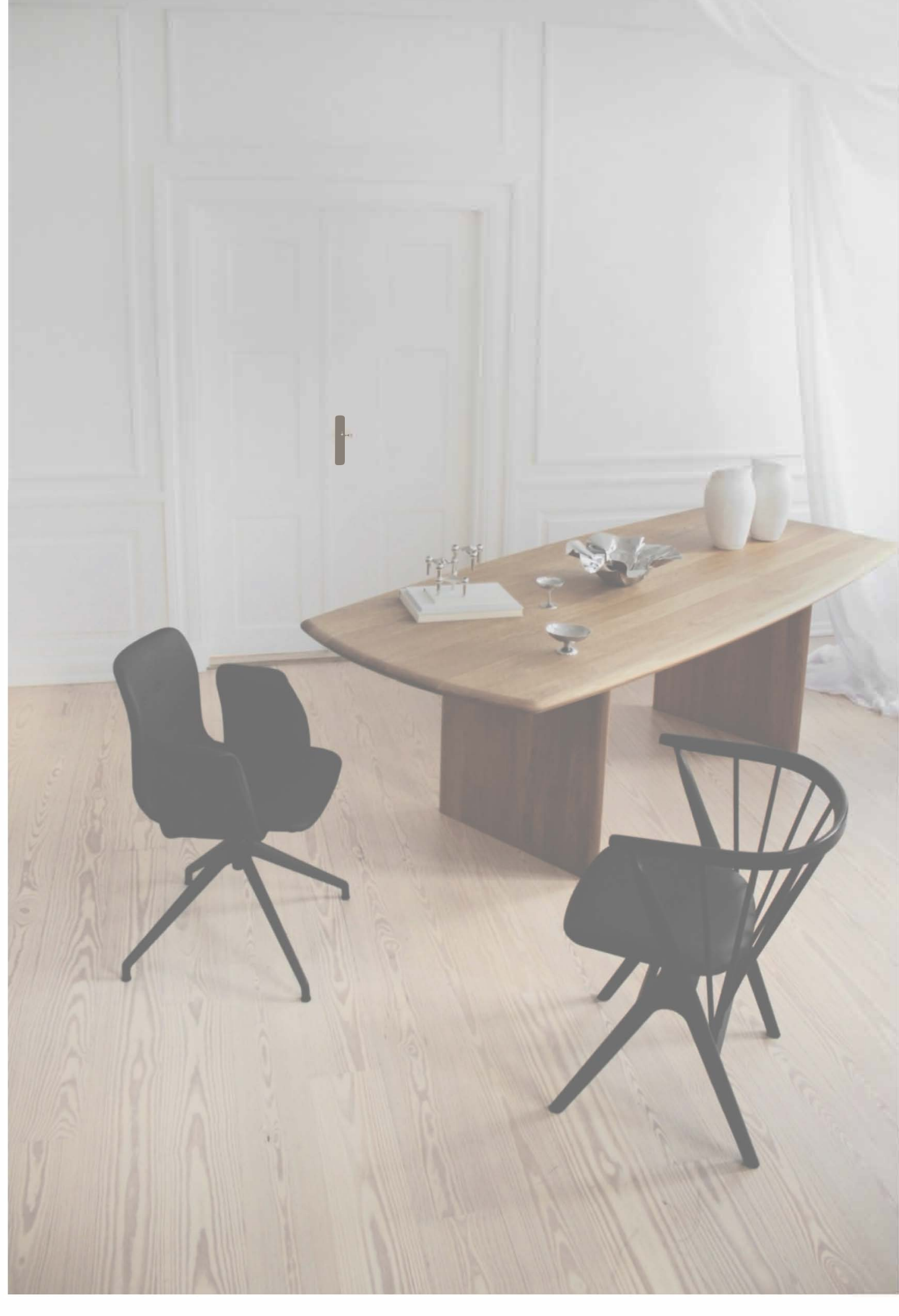

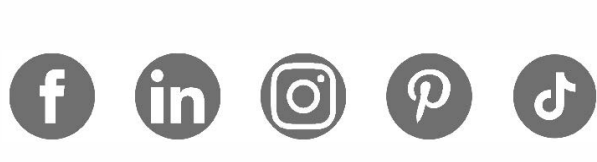
